GENERAL:

- Interested and eligible candidates may download the form available on NIHFW's website <u>www.nihfw.org</u> and submit the same duly filled in along with the application fee and all necessary documents.
- 2. The crucial date for determining age will be <u>01/07/2021</u>. Age relaxation for direct recruitment to the candidates belonging to SC/ST/OBC/Divyangjan/Ex-Servicemen/EWS etc. shall be in accordance with the rules, orders and notifications issued from time to time by the Government of India. The age limit prescribed for direct recruits may not apply to departmental candidates competing as direct recruits.
- 3. The Candidates working in Govt./Semi Govt. /PSU/Autonomous Bodies must apply through proper channel.
- 4. Mere fulfilling the essential qualifications does not entitle a candidate to be called for written examination/skill test.
- 5. Late applications/incomplete applications/interim enquiries will not be entertained.
- 6. Canvassing in any form by or on behalf of any candidate will disqualify the candidate.
