The 48th and 50th Standing Finance Committee dated 13.09.2008 and 12.11.10 respectively of the National Institute of Health and Family Welfare (NIHFW), New Delhi approved the agenda on inviting applications for the Summer Training Scheme for Research Scholars and others pursuing Masters in Public Health, Post-Graduate Diploma in Public Health Management (PGDPHM), Masters in Health Sciences, MBBS or in any of the allied field of Health and Family Welfare from recognized Universities/Institutions in India on payment basis. The Interns/ Trainees will be selected by the committee of experts during the session. The broad fields/disciplines for internship include Health Financing, Hospital Management, Demography, Bio-Statistics, National Health Programmes including NHM, HMIS, Epidemiology, Health Education and Promotion, Health Management, Health Planning and Evaluation, Public Health Policies, Social Sciences in Health, SDGs, Reproductive Bio-medicine etc.

Interested and eligible candidates may send their request through respective Head of the Institution/university/Dean along with a small CV of the candidates and recommendation of the Head of the Institution/Department/Dean to the Dean, NIHFW (dean@nihfw.org) as per the details given in the enclosed scheme document.

SUMMER TRAINING SCHEME AT THE NIHFW

This is in reference to the request of candidate to undergo summer training/Internship programme at the NIHFW. We would like to inform you that-

1. Provisional permission to the request is given subject to deposit of fees.
2. No honorarium will be paid by NIHFW to the students.
3. Facilities of short term Hostel and Food may be made available at nominal charges to be paid by the students' subject to availability and approval by the Director.
4. **THE FEES for the Laboratory Base Summer Training will be Rs. 5000/- (Rupees Five Thousand only) per month irrespective of the duration and for Non-Laboratory Base Summer Training will be Rs. 1000/- (Rupees One Thousand only) per month irrespective of the duration before joining the training programme.**

Note-The required fee has to be submitted in the form of Demand Draft / RTGES / NEFT/Online payment which is non-refundable, payable at Director, NIHFW,
