VACANCY NOTICE

The National Institute of Health and Family Welfare (NIHFW) is an Autonomous / Apex Technical Institute funded by the Ministry of Health and Family Welfare for promoting Health and Family Welfare Programme in the country through Education & Training, Research & Evaluation, specialized services, consultancy and advisory service.

The National Cold Chain and Vaccine Management Resource Centre (NCCVMRC) placed in the NIHFW is the apex body for technical support on immunization supply chain to the Government of India. The centre was established in 2013 as a joint initiative of the Ministry of Health and Family Welfare (MoHFW), NIHFW and UNICEF.

It is proposed to engage 1 (One) Technical Officer (Monitoring & Equity Immunization), 1(One) Technical Officer (Immunization Supply Chain), 1(One) Training Coordinator and 1 (One) Technical Officer (Research and Monitoring) on contractual basis at National Cold Chain and Vaccine Management Resource Centre under Universal Immunization Programme at the National Institute of Health and Family Welfare. The duration of the appointment will be initially for a period of three months. The contract may be curtailed or extended based on requirement and performance during the period:-

Job responsibilities: Addressing Equity issues in Immunization

- Conceptualize and design a mechanism for addressing equity issues in Immunization Programme.
- Advanced skills in data analysis and in synthesizing information from across data sets.
- Support in development of an immunization strategy for tribal population including conceptualization, pilot implementation and monitoring.
- Support in developing an urban immunization strategy with a special focus on urban poor and marginalized population.
- Monitor and offer quality assurance through regular field visits in states and provide feedback.
- Analysis of immunization related data to track progress on RI related activities
- Monitoring of progress in implementation of various strategies to address the equity gap in immunization.
- The above work should be conducted in close coordination and support with state and local government officials and partners as relevant.

- Ensure operational coordination of MoH&FW with States where eVIN has been handed over by UNDP
- Ensuring adoption of Good Storage Practices and Good distribution practices by states as per MoH&FW guidelines
- Facilitate eVIN scale up across all states
- Facilitate and coordinate new vaccine introduction and scale up
- Develop guidelines and SOPs as directed by the MoH&FW

Candidates with exposure to cold chain and vaccine management activities at state / national level will have an added advantage.

Job responsibilities:

The Training Coordinator will be in-charge of the NCCVMRC. He will be responsible for:

A. Training needs assessment and preparation of training database

- Assessment of training needs of cold chain technicians and cold chain officers in the states/districts
- II. Maintenance and updation of training data base of all cold chain technicians and cold chain officers, vaccine logistics managers, vaccine and cold chain handlers, etc.

B. Preparation of training plans, implementation and monitoring

- I. Preparation of training plans, methodology, manuals, kits, etc. for all trainings related to cold chain technicians and vaccine management
- II. Coordinate with Immunization Division /GMSDs and states for establishment of new cold chain training centres in different parts of the country.
- III. Preparation of training calendar in coordination with Dean of Studies, NIHFW and Deputy Director, NCCTC, SHTO-Pune and other centres / institutes
- IV. Prepare budget for different training courses and coordinate with Immunization Division, Training Division, other agencies for training funds and ensuring preparation of accounts and submission of SOEs/UCs, etc.
- V. Ensure implementation of training calendar
- VI. Ensure availability of training material (repair tool kits, broken down equipments, gas cylinders, etc.) from GMSD/neighboring states/districts for training purposes
- VII. Preparation of training of trainers courses for different trainings
- VIII. Preparation and updation of pool of trainers for different training courses
- IX. Arrange for trainers from other training centres
- X. Coordinate with states for nominations for different trainings and follow up to ensure attendance in the trainings
- XI. Preparation of training reports and submission to Immunization Division, Training Division and funding agencies
- XII. Prepare training monitoring plans in the states and districts

C. Monitoring and maintenance of NCCMIS

- Ensuring monitoring of National Cold Chain Management Information System on behalf of the MoHFW and give feedback to the states/district and Immunization Division
- II. Ensuring smooth operation of NCCMIS software, server and resolution of software issues

D. Monitoring and Evaluation

- I. Undertake studies on cold chain point mapping, Effective Vaccine Management, Cold Chain Management, equipment performance, temperature monitoring studies, cost benefit analysis of different models of cold chain maintenance.
- II. Organize meetings in coordination with partners, public and private sector enterprises and academic institutions on Cold Chain Logistics management
